1. Introduction

This Document is prepared for all suppliers who is required to furnish Data as part of Modification/Change in their information (Bank/Address/Name change/Contact details change) as a supplier in Credit Suisse

2. Purpose of the document

The purpose of this document is to outline the step-to-step process guide for suppliers to provide accurate information/documentation in Myshop S20/iValua as part of Supplier Data Modification.

3. Change Request/Modification

The Change Request/Modification of Supplier data will include the below items.

- Change in Supplier Address/Contact details/Emails
- Change/Update of Bank Details
- Change of Name/Merger/Acquisition
- Reactivation of Supplier

Please do attach all required documents while completing the change request .

4. Supplier Roles

There are 2 roles assigned to the supplier contact :

a) Supplier Admin :

- 1 Only one contact within the organization can have supplier admin role.
- 2 Can assign the admin responsibility to another contact but will then cease to be the supplier admin.
- 3 Can assign Supplier Profile Manager Role to another contact
- 4 Must attest when requested by Credit Suisse that all contacts who have access to the iValua tool are active / genuine and are associated with the company

b) Supplier Profile Manager

1. Can submit the details requested for onboarding.

As an effort towards Digitization on the supplier onboarding process, all supplier onboarding will be initiated via the lvalua supplier portal only.

The Requester i.e., your Credit Suisse Business Partner would have initiated the change request/modification of Data and subsequently submitting the request to you via the MyShopS20/lvalua.

As a supplier you would receive an automated email stating this is received from Credit Suisse Buyer/Requester (ending with @ivalua) with all login credentials to log on to lvalua.

Please click on the link to log in to lvalua using the two-facto authentication. This log in password is one time use only.

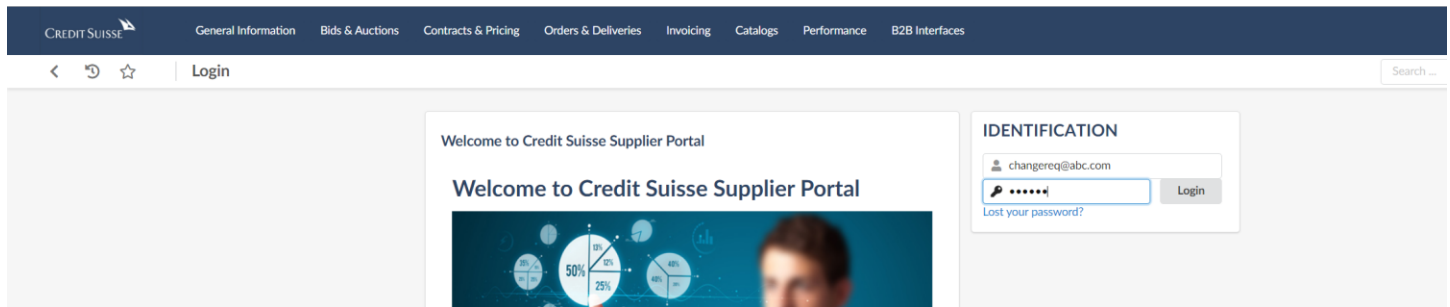
9. Step by Step procedure -Screen guide in MyShops20 /Ivalua

For a new user as the Supplier SSF Admin, you need to be familiarized with the General Terms of Use. Note your entity/company name on the right-hand top corner as highlighted here. Click on the acknowledgement and proceed. (Assuming the supplier's name here is SSF S.)

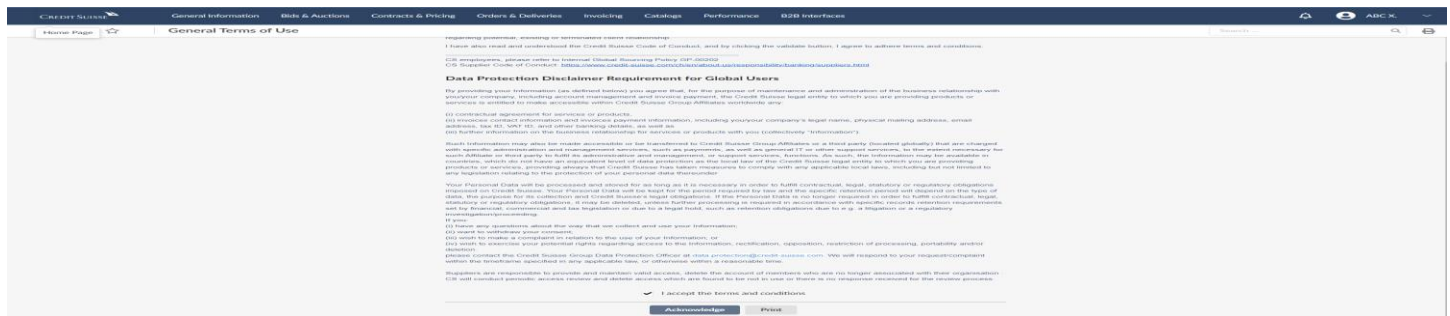
Please user another screen shot which has the revised verbiage

Log on to the Ivalua/MyShop S20 as shown below using the credentials as per the email received from Credit Suisse (look for an email ending with @ivalua) Once you enter the password as shown below, click on Login and another screen will be prompted for a verification code.

The verification code will be generated at this time and you are required to immediately check the email and input the verification code.



Click on the acknowledgement after reading through the disclaimer



Once the verification code is input , the below screen will show up. Now Click on to the Change Request Edit button as shown.

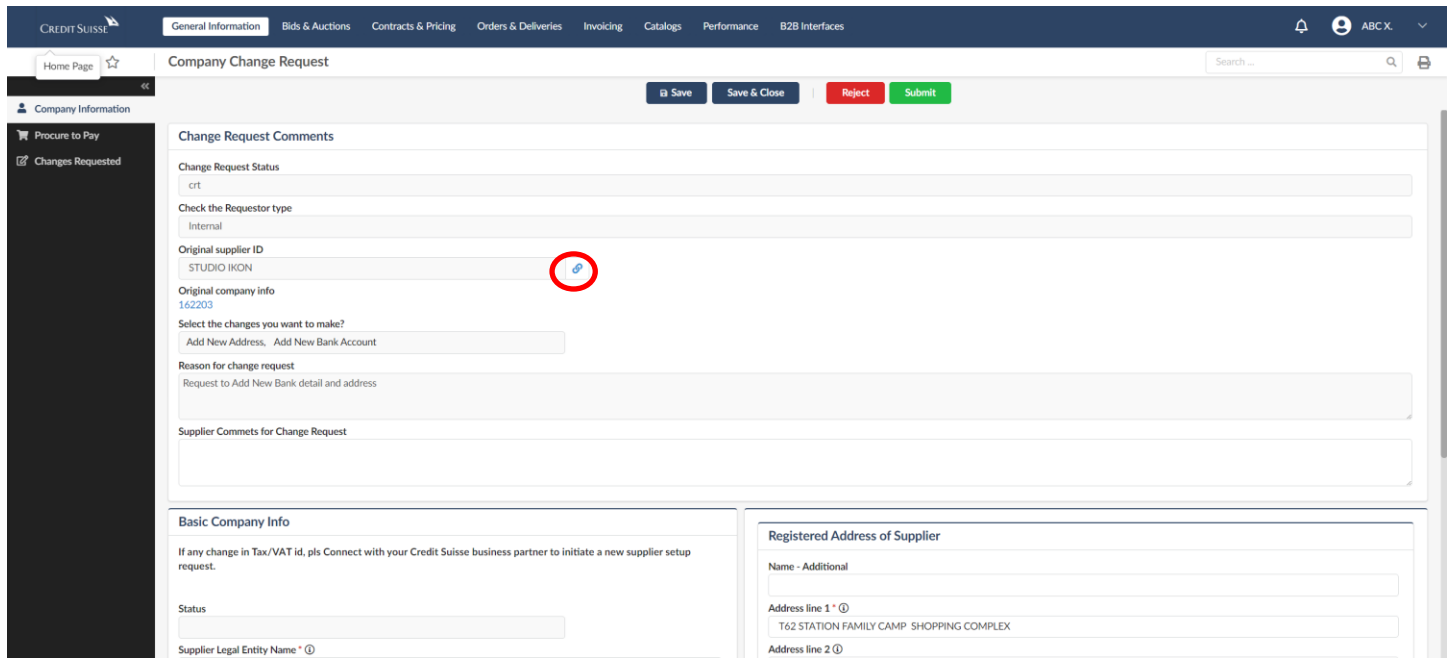

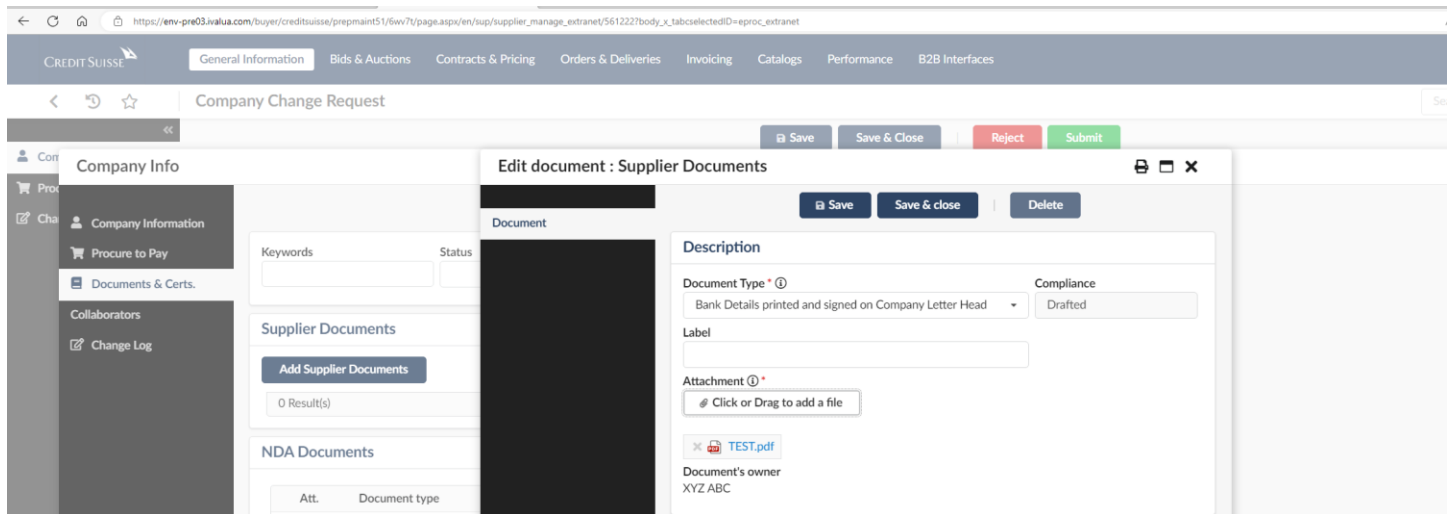

11. Status of the Ivalua Request and what they mean:

Status on the Browse Supplier page on Ivalua	Status -What does it mean ?
Supplier Approval in Progress	The form/request has reached the supplier and is pending for his action.
SDM Approval in Progress	The request is successfully submitted by the supplier and has reached Credit Suisse for further action

12. Frequently Asked Questions: (From suppliers)

Ques.1 My Login password is not working/ expired. How can I get a new one?

Ans. 1 Please email to sdml2support.myshops2o@credit-suisse.com for all login issues.

Ques. 2 Can this login be used multiple times?

Ans. 2 Yes, the log in password can be used again via two facto authentications. Everytime you input the password and hit login button , a one time verification code will be triggered. Look for this verification code email just as you login . The verification code must be input immediately once the login is done.

Ques.3 Can I recall the forms that is submitted already to Credit Suisse?

Ans. 3 Forms once submitted cannot be recalled. It is extremely important that all information is checked before submission. If any information is awaited, you may save and close the form and fill it later. If you still have missed any information, please contact the Credit Suisse Business Partner.

Ques. 4 A second email notification is received from Credit Suisse? What is this for?

Ans .4 This would mean that after Credit Suisse reviewed the request you submitted, there is a clarification or more information needed. You can see the details in the comments and act accordingly and submit it again for review.

Ques. 5 I already have a bidder ID within CS. Do I still need to fill in the forms for onboarding?

Ans. 5 Yes, bidder ids will be converted to Supplier ids and activated for contract/business purpose.

Once you receive the request from Credit Suisse for onboarding, please log on to IValua using the 2-facto authentication and complete the forms.

Ques. 6 Can I send documents/ or any other information to Business Partner in Credit Suisse for onboarding via email?

Ans. 6 No, all new supplier onboardings must be completed via the IValua portal only.

Ques. 7 Documents are not getting attached? What should I do?

Ans. 7 Please read the hover over instructions for attachments. Also please note that the name is displayed on the right top hand of the iValua portal when you log in. If you have had previous profiles, you need to select the correct and the recent profile. The validation button should be green once the documentation is attached.
