In response to the evolving worldwide regulatory requirements affecting the entire industry, UBS AG has made several changes in recent years to its legal structure to comply with too-big-to-fail legislation. As part of these changes, the Swiss Asset Management business, currently in UBS AG, will be transferred to a new Swiss legal entity, UBS Asset Management Switzerland AG, a member of the UBS Group.

UBS Asset Management Switzerland AG will take over the existing business relationships from UBS AG, Asset Management by way of a transfer of assets and liabilities pursuant to the Swiss Merger Act which allows for a transfer by operation of law. Effective 17 June 2019, UBS Asset Management Switzerland AG will be responsible for providing the services under the portfolio management and distribution agreements, replacing UBS AG, Asset Management. UBS Asset Management Switzerland AG has obtained an Asset Manager CIS (collective investment schemes) license from the Swiss Financial Market Supervisory Authority (FINMA). This change is not expected to cause substantial changes to the existing operational processes or how UBS Asset Management serve clients.

The aforementioned change shall be reflected in an updated version of the prospectus dated June 2019 which will be made available to shareholders at the registered office of the Company.

In Reaktion auf die sich ändernden regulatorischen Anforderungen an die gesamte Branche weltweit hat die UBS AG in den letzten Jahren an ihrer Rechtsform mehrere Änderungen durchgeführt, um den neuen gesetzlichen Vorschriften für systemrelevante Finanzinstitute gerecht zu werden. Im Zuge dieser Änderungen wird das Schweizer Asset-Management-Geschäft, das derzeit innerhalb der UBS AG betrieben wird, auf einen neuen Schweizer Rechtsträger, namentlich die UBS Asset Management Switzerland AG, ein Mitglied der UBS Group, übertragen.

UBS Asset Management Switzerland AG wird von UBS AG, Asset Management sämtliche bestehenden Geschäftsbeziehungen übernehmen. Dies soll durch die Übertragung der Aktiva und Passiva gemäss dem Schweizerischen Fusionsgesetz (FusG) erfolgen, das eine Übertragung kraft Gesetz ermöglicht. UBS Asset Management Switzerland AG wird mit Wirkung vom 17. Juni 2019 für die Dienstleistungen gemäss den Portfoliomanagement- und Vertriebsvereinbarungen verantwortlich zeichnen und UBS AG, Asset Management ersetzen. UBS Asset Management Switzerland AG hat von der Eidgenössischen Finanzmarktaufsicht (FINMA) eine Lizenz als Vermögensverwalter von kollektiven Kapitalanlagen erworben. Es ist nicht zu erwarten, dass diese Entwicklung zu wesentlichen Änderungen der bestehenden operativen Prozesse oder der Art und Weise, wie UBS Asset Management die Kunden betreut, führen wird.

Der vorstehend erwähnten Änderung wird in einer aktualisierten Version des Prospekts, datiert auf Juni 2019, Rechnung getragen, die den Aktionären am Gesellschaftssitz zur Verfügung stehen wird.

Face à l'évolution des exigences réglementaires aux quatre coins du monde, qui touche l'ensemble du secteur, UBS AG a apporté divers changements à sa structure juridique au cours de ces dernières années afin de se conformer à la législation relative aux banques dites « too big to fail » (trop importantes pour faire faillite). Dans le cadre de ces changements, l'activité de gestion d'actifs en Suisse, actuellement prise en charge par UBS AG, sera transférée à une nouvelle entité juridique suisse, à savoir UBS Asset Management Switzerland AG, un membre du groupe UBS.

UBS Asset Management Switzerland AG reprendra les relations d'affaires existantes d'UBS AG, Asset Management par voie de transfert des actifs et des passifs en vertu de la loi suisse sur la fusion, qui prévoit une telle situation. À compter du 17 juin 2019, UBS Asset Management Switzerland AG sera responsable de la prestation des services prévus par les contrats de gestion de portefeuille et de distribution, en remplacement d'UBS AG, Asset Management. UBS Asset Management Switzerland AG a obtenu une licence de Gérant de fortune de placements collectifs de capitaux auprès de l'Autorité fédérale de surveillance des marchés financiers (FINMA) en Suisse. Ce changement ne devrait pas avoir d'incidence significative sur les processus opérationnels existants, ni sur les services fournis par UBS Asset Management à ses clients.

Le changement susmentionné sera reflété dans une version actualisée du prospectus datée de juin 2019, qui sera mise à la disposition des actionnaires au siège social de la Société.

Alla luce dell'evoluzione delle disposizioni regolamentari a livello globale che interessano l'intero settore, negli ultimi anni UBS AG ha apportato diverse modifiche alla sua struttura legale per conformarsi alla normativa sugli istituti "troppo grandi per fallire". Nell'ambito di queste modifiche, le attività di asset management in Svizzera, attualmente di competenza di UBS AG, saranno trasferite a una nuova entità svizzera, UBS Asset Management Switzerland AG, membro di UBS Group.

UBS Asset Management Switzerland AG rileverà le relazioni commerciali esistenti di UBS AG, Asset Management mediante trasferimento delle attività e delle passività ai sensi della Legge sulle fusioni svizzera, che prevede un trasferimento "de iure". Con effetto a decorrere dal 17 giugno 2019, UBS Asset Management Switzerland AG sarà responsabile della fornitura dei servizi disciplinati dai contratti di gestione di portafoglio e di distribuzione in sostituzione di UBS AG, Asset Management. UBS Asset Management Switzerland AG ha ottenuto l'autorizzazione come gestore di investimenti collettivi di capitale dall'Autorità federale di vigilanza sui mercati finanziari (FINMA). Questo cambiamento non dovrebbe influire in misura significativa sui processi operativi esistenti o sul modo in cui UBS Asset Management serve i suoi clienti.

La suddetta modifica sarà integrata in una versione aggiornata del prospetto informativo datata giugno 2019, che sarà messa a disposizione degli azionisti presso la sede legale della Società.

En respuesta a un entorno regulatorio cambiante a escala mundial, que afecta al sector en su conjunto, UBS AG ha efectuado varios cambios en su estructura legal en los últimos años con el propósito de cumplir con el régimen normativo conocido como «demasiado grande para caer» (*too big to fail*). Como parte de estas modificaciones, su negocio en el ámbito de la gestión de activos en Suiza, que en la actualidad corre a cargo de UBS AG, se transferirá a una nueva entidad jurídica suiza, UBS Asset Management Switzerland AG, firma que forma parte del grupo UBS.

UBS Asset Management Switzerland AG asumirá las relaciones mercantiles existentes de UBS AG, Asset Management por medio de una transferencia de activos y pasivos con arreglo a la Ley de Fusiones suiza (*Swiss Merger Act*), que permite las transferencias en virtud de la ley. Con efecto a partir del 17 de junio de 2019, UBS Management Switzerland AG se encargará de prestar los servicios contemplados en los contratos de distribución y gestión de carteras, en sustitución de UBS AG, Asset Management. UBS Asset Management Switzerland AG ha obtenido una licencia de gestor de activos para organismos de inversión colectiva de la Autoridad Supervisora del Mercado Financiero de Suiza (FINMA). No se prevé que esta modificación traiga consigo cambios sustanciales en la operativa existente o en cómo UBS Asset Management presta servicio a los clientes.

La modificación citada con anterioridad se reflejará en la versión actualizada del folleto de junio de 2019, que se pondrá a disposición de los accionistas en el domicilio social de la Sociedad.
