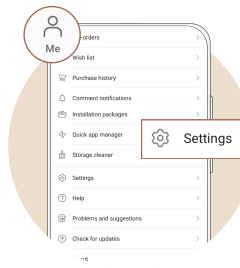

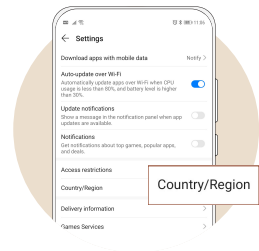
1. Launch the Huawei AppGallery store.



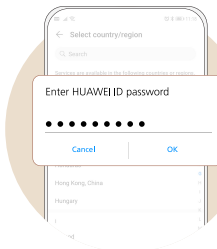
2. Select "Me" and open "Settings".



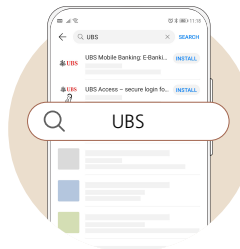
3. Change the "Country/Region" to "Hong Kong, China" or "Singapore".
