
# Navigate to Structured Products Digital

1. You can enter a structured products transaction in UBS E-Banking via: 'Markets & Trading' → 'Customize structured product'



- **2.** Select portfolio and choose product type.

- **3.** Search for an underlying asset using its name, symbol, ISIN or RIC.

Details will be reflected through UBS Quotes. Click 'Select' next to the instrument you wish to include.







- **4.** Enter order details, eg. Investment amount, Order Type, Tenor and other relevant parameters.



UBS' quote (if available) will always be displayed first. Quotes from other issuers will be sorted by economic term e.g. coupon rate.












### **Validation**

6. Click on 'Requote' if you need to update the parameters. Please note that by making this selection, you are requesting an updated quote from the issuer selected.


If you want to select another issuer click on 'Previous' and restart the validation process.


